Booking

1) For our off-the-shelf Training Programmes (Teambuilding, Challenge etc.) the minimum number of participants in a group is 20. You would be still be charged for 20 people even if your group size is less than 20. For group sizes of 20 or more you will be billed at actual. If an exception has been made to this arrangement, please attach the letter/email from Magic Bus which specifies this, alongwith this booking form.

2) If you have any special requests, we would appreciate if you advise us at the time of booking and clearly mention them on the booking form.

3) Magic Bus will not be responsible for any delays and alterations to the programme incurred due to natural hazards, flight cancellations, bus delays, weather, sickness, landslides, political closure or any untoward incident. Light rain or merely a forecast of adverse weather will not affect the schedule.

Payment

We will confirm your booking on receipt of 25% advance of your invoice amount. The remaining 75% of the invoice value must be received 8 days in advance of the event date. If you do not make your payment by this date this will be a breach of the contract between us, entitling us to consider the booking as cancelled by you and to apply cancellation charges as set out in these booking conditions. Cancellations charges apply if there is a change of date after the booking form has been signed.

Cancellation Charges

In case of cancellation or date changes the following charges will apply as a percentage of the invoice amount:

More than 15 days prior to the event date	10%	Less than 3 days prior to the event date	50%
Between 15 and 3 days prior to the event date	25%	Failure to attend	100%

Insurance

We provide personal accident insurance to all participants of our programme, during their stay. Our accident policy only covers accidents whilst undergoing the programme and does not cover any pre-existing ailments. Magic Bus will not be financially liable for any accidents.

Health

Medical declaration forms will be sent to you after booking confirmation. We require completed forms by all participants to be returned at least 1 day prior to the event date. No event takes place at the Centre if Medical Forms have not been received

Liability

If the instructions of the Magic Bus staff or its support personnel are not followed, all liability of Magic Bus shall lapse.

Activities and Risk

Participants will have the opportunity to play or engage in supervised games, and experience rock climbing, rappelling, balancing and working with others on artificial structures. They also may experience nature walks, activities on the river or treks to local hills. Because of where we are and what we do, we expose children and adults to environmental, physical and mental challenges. We reduce risks presented by these challenges using a process of close supervision, continual inspection and detailed documentation of health and safety procedures for our staff to follow. We however cannot name, control or remove every kind of risk, as learning is enhanced by perceived and safely controlled risk. You therefore need to understand there are risks that can result in an injury. We do not want to frighten you but want you to be conscious of the fact that activities do include some inherent risk and that Magic Bus is no under liability whatsoever in retrospect to loss or damage of life, limb and property while attending the programme.

Health

- 1) No previous training or experience is required to take part in our activities but we need to know if there are any participants with restrictive health conditions or injuries. All information given to us in the medical form is held in the strictest of confidence.
- 2) To prevent injury we require participant to follow all reasonable instructions given by authorized staff. We also reserve the right to exclude any participant from an activity, or a programme on the grounds of health.
- 3) Dhirubhai Ambani Hospital with world class facilities is located only 5 kms away from the Centre and is fully equipped to take care of any emergencies.

Behaviour

- 1) Magic Bus reserves the right to exclude any participant from a planned activity, or the programme, if their actions are thought to endanger their safety or the safety of others. No refund of fees is available to anyone and we will not pay any expenses or costs incurred as a result of the termination of the programme.
- 2) Consumption of alcohol, smoking and outside food are not permitted within the Magic Bus Centre for Learning & Development .

Personal Property
